


NIROPS Website

- Refreshed the content on the "About", "Documents/Reports" and "Imagery" pages.
- Updated web links on the "Links" page.
- Added "NIFS Workflow" and "Feedback" pages.



IR Online Ordering

- Issues during 2021 season
 - Overall, Online Ordering was stable through the fire year.
 - Internet Explorer has aged to the point that it can't be used to submit requests.
- Modifications for 2022 season?
 - Submit your requests soon so we can compile and prioritize a list for the web developer.



NIROPS2KML Tool

- Identified need to modify existing tool to ingest feature classes from geodatabases as well as shapefiles.
- Still a work in progress
 - Shapefiles are simple, geodatabases not so much.
 - Staff availability
 - Should have modified tool by next spring
- Vertex limit for KMZs.
 - Apparently, there is a 30 40K (?) vertex limit when converting shapefiles to KMZs.
 - Encountered this on the "larger" fires this year.
- Inconsistent errors

NIROPS Website Usage Summary

April 1 – November 17

- 36,513 visits to the website; 9,769 unique visitors
- 82.4% of visits were from desktop and laptop computers.
- 17.6 % of visits were from mobile devices
 - Tablets 2.3 %
 - Mobile 15.3 %



Aircraft3 Summary

- Overall, it was a quiet support season.
- Like 2020, EU IR contract vendors and CWN IR vendors reduced need for Aircraft3 support.
- USGS analysts shadowed NGA analysts.
- Incident support started on April 26
 - Flag Fire, AZ
- Incident support ended on September 13 (?).
 - Greenwood Fire, MN
- 22 days of continuous support from 8/20 9/13.


Extended Incident Support
